#### **Terms and Conditions**

Welcome to the bookshop.ge website ("English Book Education" website), a website owned and operated by English Book Education.

The terms and conditions stated below, along with the policies and guidelines located throughout the onlinebookshop.ge Site (collectively herein the "Terms of Use") identify what a user of the onlinebookshop.ge Site ("you" or "your" or "User" or "Users") can expect from English Book Education, (referred to herein as "English Book Education", "we", "us" or "our"), and/or persons who provide products or services to English Book Education customers either directly or through the onlinebookshop.ge Site and what English Book Education in turn expects from Users.
